Note (1) - Proposed Capital Reorganisation :

- (i) Consolidation of every ten (10) issued shares of HK\$0.01 each into one (1) consolidated share of HK\$0.10 each (the “Consolidated Share”);
- (ii) Reduction of the issued share capital by a cancellation of the paid up capital to the extent of HK\$0.09 on each of the then Consolidated Shares such that the nominal value of each issued Consolidated Share will be reduced from HK\$0.10 to HK\$0.01; and
- (iii) Adjusted Shares being ordinary shares of HK\$0.01 each in the share capital immediately upon the Capital Reorganisation becoming effective.

Note (2) - Proposed Open Offer :

944,926,950 Offer Shares are proposed to be offered to the Qualifying Shareholders under the Open Offer for the subscription on the basis of five (5) Offer Shares for every one (1) Adjusted Share held on the Record Date.

Details of the Proposed Capital Reorganisation and the Proposed Open Offer were set out in the circular dated 9 March 2015.
