The Board wishes to inform the shareholders of the Company and potential investors that based on the preliminary review of the unaudited consolidated management accounts of the Group, it is expected to record a greater loss for the year ended 30 June 2015 as compared to the loss recorded for the corresponding year of 2014.

The information contained in this announcement is only a preliminary assessment by the Board based on the information currently available and the unaudited consolidated management accounts of the Group, which have not been reviewed, confirmed nor audited by the Company's independent auditors.

This announcement is made by Solartech International Holdings Limited 蒙古礦業控股有限公司* (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance) (Chapter 571 of the Laws of Hong Kong (the “**SFO**”).

Based on the latest review by the board of directors of the Company (the “**Board**”) of the unaudited consolidated management accounts of the Group, the Board wishes to inform the shareholders of the Company and potential investors that the Group is expected to record a greater loss for the year ended 30 June 2015 as compared to the loss recorded for the corresponding year of 2014. Based on the relevant information currently available to the Company, the Board considers that the greater loss was mainly attributable to (1) the loss on change in fair value of derivative financial instruments; (2) the loss on change in fair value and loss on disposal of financial assets; (3) the impairment loss for doubtful debts; and (4) the impairment loss recognised in respect of mining rights.

As the Company is still in the course of preparing its audited final results for the year ended 30 June 2015, the information contained in this announcement is only a preliminary assessment by the Board based on the information currently available and the unaudited consolidated management accounts of the Group, which have not been reviewed, confirmed nor audited by the Company’s independent auditors. The overall financial results of the Group for the year ended 30 June 2015 will only be ascertained when all the relevant results and corresponding treatments are finalised. The audited final results of the Group for the year ended 30 June 2015 will be announced by the Company on 29 September 2015. Shareholders of the Company and potential investors are advised to read the audited final results announcement of the Company when it is published.
