EXTENSION OF LONG STOP DATE IN RESPECT OF THE SHARE PURCHASE AGREEMENT

Reference is made to the joint announcements of Solartech and Hua Yi dated 15 October 2007, 14 November 2007, 27 November 2007 and 24 December 2007 in relation to the Share Purchase Agreement, pursuant to which Hua Yi has agreed to acquire the entire issued share capital of the Target Company. Reference is also made to the circulars of Solartech and Hua Yi both dated 31 December 2007 in relation to the Share Purchase Agreement. The parties to the Share Purchase Agreement have agreed to extend the deadline for satisfaction of the conditions precedent under the Share Purchase Agreement to 30 April 2008.

BACKGROUND

Reference is made to the joint announcements of Solartech International Holdings Limited (“**Solartech**”) and Hua Yi Copper Holdings Limited (“**Hua Yi**”) dated 15 October 2007, 14 November 2007, 27 November 2007 and 24 December 2007 in relation to the Share Purchase Agreement, pursuant to which Hua Yi has agreed to acquire the entire issued share capital of the Target Company. Reference is also made to the circulars of Solartech and Hua Yi both dated 31 December 2007 (the “**Circulars**”) in relation to the Share Purchase Agreement. Capitalised terms used herein shall have the same meanings as those defined in the Circulars unless the context herein requires otherwise.

Share Purchase Agreement

Pursuant to the Share Purchase Agreement entered into between the Vendor and Hua Yi, the Vendor agreed to sell and the Purchaser agreed to purchase the Sale Shares.

Pursuant to clauses 2.1 and 2.4 of the Share Purchase Agreement, Completion is subject to the satisfaction of the conditions precedent set out under clause 2.1 of the Share Purchase Agreement on or before 31 March 2008 (the “**Long Stop Date**”).
